We hereby surbually agree that all of the property which shall hereafter be acquired by atther of us, whether separately, jointly or otherwise, and of whatsoever nature and sixuated in the State of Washington, shall be and it is hereby declared to be community property, such each of the parties does hereby convey and transfer

to the other and to the community all such property hereafter acquired by either of them, even though the same be acquired in his or her separate astate; and

AT IS FURTHER AGREED that the whole of the community now owned by us or hereafter acquired by us in the State of Washington, including all property the status
of which is changed or created by this agreement, shall at once, in the event of
the death of Jerry D. Shepard while the said Arlene B. Shepard survives, be
vested in Arlene B. Shepard absolutely and in fee simple as her cole and separate
property; and in the event of the death of the said Arlene B. Shepard while the
said Jerry D. Shepard survives, then the whole of the community property now crased
by us or hereafter acquired by us in the State of Washington, including all property
the status of which is changed by this agreement, shall at once west in the said
Jerry D. Shepard absolutely and in fee simply as the sole and apparate property.

IT IS FURTHER AGREED that the single enception to this agreement and I be 23 acres more or less situated in Sec. 27, Two. N. R. 7 E. W. I., Skemmis County adjoining the U.S. Nursery and Forest Service and most of the present Walter and Mary Jane Locride property per attached county map and known as parcals # 1 and # 2 which shall be deeded directly to the children of Jerry D. Shepard upon his death as discribed in his Last Will and Testament. Arlene B. Shepard hereby assigns any and all interests in this 23 acres to the seven children of Jerry D. Shepard upon the death of Jerry D. Shepard.

IT IS FUNTHER AGREED that this community property agreement shall pertain only to real and personal property situated in the State of Washington.
