IN THE MATTER OF SSH No. 8-C, Wind River Bridge Vicinity (Surplus Land).

KNOW ALL MEN BY THESE PRESENTS, that the STATE OF WASHINGTON, for and in consideration of FIFTY AND NO/100 DOLLARS (\$50.00) hereby conveys and quitclaims unto SKAMANIA COUNTY, a political subdivision of the State of Washington, all its right, title and interest, in and to the following described real property situated in Skamania County, State of Washington:

Those portions of Government Lot 4, Section 8, Township 3 North, Range 8 East, W.M., lying northeasterly of that right of way line drawn parallel with and 75 feet northeasterly, when measured at right angles, from the survey line of former Secondary State Highway No. 8-C, Wind River Vicinity, now a County Road, and being southwesterly of the right of way of the High Bridge Road, as said right of way existed prior to April 17, 1956.

The specific details concerning all of which may be found on sheet 3 of that certain plan entitled SSH No. 8-C, Wind River Bridge Vicinity, now of record and on file in the office of the Secretary of Transportation at Olympia, Washington, bearing date of approval April 17, 1956.

The lands herein described are not required for State highway purposes and are conveyed pursuant to the provisions of RCW Chapter 47.12.
