welfare, do by these presents grant, convey and dedicate to Skamania County,

State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of Skamania State of Washington:

A right of way as required for the County Road known and designated Wedrick Road, County Road No. 32720 located in the Joseph Robbins D.L.C. #38 in Section 27, Township 3 North, Range 8 East W.M. in Skamania County, Washington. More particularly:

A right of way 20 feet in width, lying southerly of and contiguous to the following described line.

Beginning at a point on the west line of the Gunnar Johnson tract as described in deed recorded at Page 418, Book U of Deeds, Records of Skamania County, Washington, said point lying North 682 feet and East 660 feet from the intersection of the west line of Jos.
