File No. 84429, Records of Skamania County, Washington,

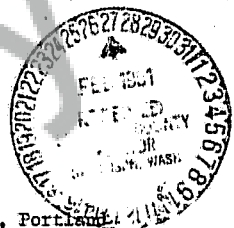
Reserving to the United States of America the right to grant easements to public
