hereby conveys and quitclaims to the City of North Bonneville, a municipal corporation of the State of Washington,

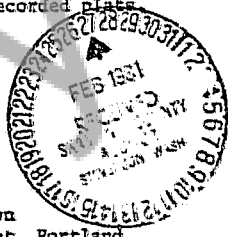
