all of its right, title and interest in the following described real property situated in the County of Skamania, State of Washington, to wit:

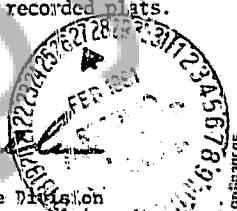

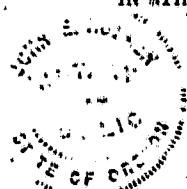
