 Skamania County, Washington.

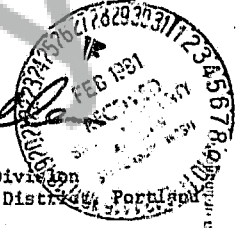
Reserving to the United States of America the right to grant easements to public
