THREE HUNDRED FIFTEEN and 00/100 DOLLARS----- (\$315.00), hereby conveys and quitclaims to the City of North Bonneville, a municipal corporation of the State of Washington, and

all of its right, title and interest in the following described real property situated in the County of Skamania, State of Washington, to wit:

Reserving to the United States of America the right to grant easements to public utilities to erect, construct, operate and maintain public utility facilities on, over and under the utility easement(s), if any, as shown on said recorded plats.
