DEDICATION DEED

GRANTOR(S) August M. Paasch and Nelja A. Paasch, Husband & Wife

for and in consideration of the sum of Ten Dollars and other valuable considerations (\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to Skamania County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of Skamania, State of Washington:

A right of way as required for Erickson Road, County Road No. 32260, located in Section 26, Township 3 North, Range 8 East N.M., in Skamania County, Washington.

More particularly:

That right of way being 30 feet on the right side of the following described Erickson Road centerline from the Point of Beginning to the point 590.47 feet distance from the Point of Beginning. Also a triangular section on the left side being 30 feet wide at its apex and the base thereof extending from a point located 450 feet from the Point of Beginning along the Erickson Road centerline to a point 578.55 feet distance from said Point of Beginning.

Centerline Description

Beginning at the Point of Beginning, said point being 792.99 feet East and 519.63 feet North of the Southwest corner of Section 26, Township 3 North, Range 8 East W.M., thence N 81°39'32" W 357.96 feet to the P.C., thence on a 156.76 feet radius curve to the right 220.59 feet to the P.T., thence N 01°02" W 11.92 feet.

Said parcel containing ±0.25 acres.
