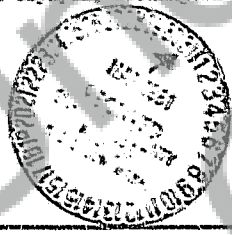

That this affidavit is made pursuant to RCW 11.62.010(2)
