EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this April , 19 81 by and between BROUGHTON LUMBER COMPANY, a Bashington corporation, herein called "Broughton," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein culled "State," WITHESSETH:

Whereas, on the 30th day of May, 1979, Broughton and the State entered into an essement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington, on the 20th day of June, 1979, in Wolume 76 of Deeds, pages 715-722 under Auditor's File No. 88809. Said Original Easement is hereby supplemented as follows:

Ι,

A. Broughton for and in consideration of a similar grant to be made by the State parsuant to RCW 79.38.020 hereby grants and conveys to State, its successors and assigns, pursuant to RCW / 7.32.020 hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way twenty (20) feet in width for existing roads and forty (40) feet in width for new construction, over and across SE1/4SW1/4, Section 1, E1/2W1/2, SW1/4SE1/4, Section 12, Township 3 North, Range 9 East; W1/2NW1/4, Section 7, Township 3 North, Range 10 East, W.M., in Skamania County, Washington. Said roads located approximately as shown in red and yellow on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

- B. It is agreed that the State shall construct the roads shown in yellow on the attached Exhibit A to the agreed upon road standard.
- C. Provided, however, thirty (30) days prior to any construction, reconstruction, or development, the State shall submit to Broughton, for written approval, a complete and detailed plan of operation for the development of the right of way. The State's operations specified hereinabove shall be conducted in accordance with the provisions of the approved Plan of Operation in force at the time of the commencement of said operations and the State shall provide for the examination of the right of way with Broughton's representative, before any construction, reconstruction, or development is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.


