We, the undersigned, being the owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way variable feet in width over and across the following described piece or parcel of land, to-wit:

Additional right-of-way as required for the County Road known and designated Cook-Underwood Road (County Road No. 93041) located in the southeast quarter of the southeast quarter (S.E. 1/4, S.E. 1/4) of Section 15, Township 3 North, Range 10 East, W.M. in Skamania County, Washington, more particularly:

CENTERLINE DESCRIPTION

Begin: at Engineer's Station P.O.C. 70+50 (Cook-Underwood Road) said point being the intersection of the centerline, Cooper Avenue and Cook-Underwood Road and said P.O.C. Station lying north 425.39 feet and west 309.13 feet from the County monument marking the southeast corner of Section 15, Township 3 North, Range 10 East, W.M. and a high point the radial line bears S 8° 56' E; thence following a 10° 00' curve to the left 237.30 feet to P.T. Station 72+87.30; thence S 57° 20' W 112.70 feet to Station 74+00.

EASEMENT DESCRIPTION

An easement lying southerly of the above described centerline and being 90 feet in width from Station 70+50 to Station 72+50, thence to a point 70 feet left from Station 73+50, thence 70 feet in width from Station 73+50 to Station 74+00. Excepting existing rights-of-way. Containing 0.19 acres more or less.

and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a County Road.
