DEED AND BILL OF SALE

PACIFICORP, a Maine corporation, doing business as PACIFIC POWER & LIGHT COMPANY (Pacific), for and in consideration of Thirty Thousand Dollars (\$30,000.00), the receipt of which is hereby acknowledged, does hereby bargain, sell and convey unto PUBLIC UTILITY DISTRICT OF CLARK COUNTY, a municipal corporation of the State of Washington (PUD), a portion of Pacific's Condit-Camas 69 kV (Beacon Rock Line) Transmission Line facilities and appurtenances thereto situate in Clark and Skamania Counties, Washington and described as follows:



Approximately 8½ miles of the Condit-Camas 69 KV (Beacon Rock Line) beginning at structure #10/40 in Section 6, Township 1 North, Range 5 East, W.M. in Skamania County, Washington and proceeding thence westerly to and including structure #4/49 in Section 11, Township 1 North, Range 3 East, W.M. in Clark County, Washington.

Pacific shall assign to PUD by a separate instrument all easements, permits and licenses currently vested in Pacific for the operation and maintenance of the electric transmission facilities.

Pacific warrants that it is the owner of and has good title to the properties conveyed hereby. Pacific makes no warranties with respect to the condition, merchantability or fitness for any particular use of said electric transmission facilities.

PUD will indemnify and hold Pacific harmless against and from any and all claims, demands or liability for injuries to persons or damage to property caused by or in any way arising out of the operation, repair, maintenance or removal of said electric transmission facilities.

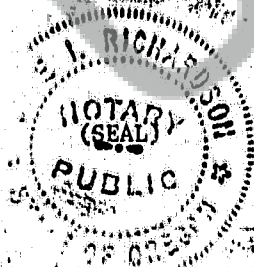

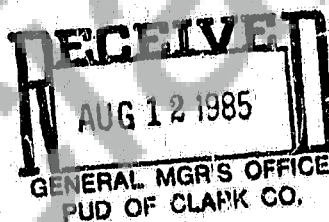
