	<ol> <li>History of Corner Establishment and Subsequent Restoration; description of Evidence Found:</li> </ol>
	I found no evidence of the 6-inch diameter Dogwood and the 48-inch diameter Fir
	called for in the 1875 GLO Notes. However, the Skamania County Road Records show
	this corner tied into the March, 1923 survey of Laycock Road. In July, 1925, the
	Road was extended past this one-quarter corner and the Road was called the Laycock-
	Kelchner Road. These plans also show the East one-quarter corner of Section 16.
	The distance West of Laycock-Kelchner Road is shown as 174 feet. On April 13, 1981,
	I found the remains of the three-way fence corner (North-South and East) very close
	to the position shown on the 1923 and 1925 Road surveys. The vegetation difference
	(ie. old field on the West and large timber on the East) plus the condition of the
	fence and a large back furrow from years of plowing indicate that this had been the
	use line for many years. I re-established the location of the old fence corner and
	monumented it as shown in item 2.
