2. Description of Evidence Found:

U.S.F.S. 2 1/2" Brass cap on a 1" iron pipe set by U.S. Dept. of Agriculture.
 Location fits original call of top of ridge at 76.00 ch. on South line of Section.
 Corner in R/W of road. Orig. BT's most likely destroyed by road construction.

See Wind River Experimental Forest Timber Survey Report-1933 corner listed as set from original evidence.
