1. History of Corner Establishment and Subsequent Restoration:

GLO in 1878 set a post for this corner from which bear: 6" fir, West, 12 links. No other trees convenient, dug trench & pit.  
GLO in 1893 retracement made same call.  
Longview Fibre Co. in 1968 set this corner by proportion, with a 1 1/4" pipe, from which bear:  
24" fir, N33E, 51.45 ft. to face scribed 1/4S19  
14" fir, S60E, 14.20 ft. to face scribed 1/4S19

2. Description of Evidence Found:

No original evidence. Found 1 1/4" pipe protruding 6" above ground.  
Found both witness trees in good condition and marked with Longview Fibre Co. tags.

Accepted position of pipe as the true corner

3. Describe Monument, Accessories and Corollary Data to Perpetuate this Corner Location. Diagram corner and indicate meridian and reference to map of record. Surveyor's Field Book No. 30819. Page No. 4. Date of work February 15, 1982.

1 1/4" stainless pipe protruding 6" above ground, from which bear:

32" D-fir, N33E, 51.45 ft. to scribed face  
20" D-fir, S60E, 14.20 ft. to scribed face

Both faces are nearly healed. Above calls are record bearing and distance. Tags are in good condition
