1. History of Corner Establishment and Subsequent Restoration:

This corner was originally set by Deputy Lewis D.W. Shelton in July 1899, Oct.-Dec. 1900 under Contract No. 552.

Remonumented by Floyd A. Brooks, Cadastral Surveyor in Oct. & Nov. Set Iron post with Brass cap.

2. Description of Evidence Found:

- BIM 2 1/2" Iron post with Brass cap.
- Orig. 12" now 16" D-Fir snag N50°E-19 lks. scribing visible on opened blaze.
- Orig. 10" now 2 1/4" Cedar S12°E-22 lks. opened blaze.
- Orig. 14" now 2" uprooted sawed stump stood S32 3/4°W-16 lks. healed blaze.
- Orig. 16" now 16" rotted stump N24°W-28 lks..
- Brooks 9" now 11" down Wh. Fir snag stood N68 1/2°E-26 lks. healed blaze.
- Brooks 16" now 18" D-Fir S6E-29 lks. healed blaze.

New Bearing Trees:

- 9" Hemlock N28°W, 30.2 ft. scribed T.M.R.6ES17 upper blaze and a lower blaze scribed BT and with a 3/4" Brass disk stamped PLS 16337.
- 9" Hemlock N°3E, 37.0 ft. scribed T.M.R.6ES15 upper blaze and a lower blaze scribed BT and with a 3/4" Brass disk stamped PLS 16337.

Set guard posts East and South with sign 54-4 and BM 102 decal.
 Nailed 54-4 and BT signs to BT's and painted band and blazes red.
