### 2. Description of Evidence Found:

BM 2 1/2" Iron post with Brass cap.

Brooks 16" now 20" uprooted D-Fir sawed stump stood N12W-40 lks. healed blaze.

Brooks 20" now 24" uprooted Hemlock stood S87W-56 lks. healed blaze.

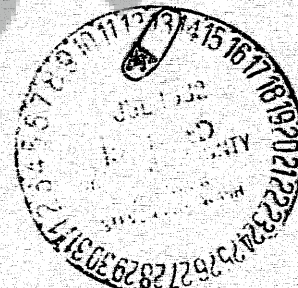
#### New Bearing Trees:

18" Hemlock S12W, 33.6 ft. scribed 1/8" S22 upper blaze and a lower blaze scribed BT and with a 3/4" Brass disk stamped PLS 16337.

8" Wh. Fir N23E, 51.0 ft. scribed 1/8" S15 upper blaze and a lower blaze scribed BT and with a 3/4" Brass disk stamped PLS 16337.

Set guard post East with sign 54-4 and BM 102 decal.

Nailed 54-4 and BT signs to BT's and painted band and balzes red.
