 Scribed 10" Fir N44E-28 lks.. Scribed 19" Fir N50E-34½ lks..
 12" Fir S62E-35 lks.. Scribed 13" Hemlock S70W-71 lks..
 7" Hemlock S81½W-26 lks..
 10" Hemlock N71W-27 lks..

2. Description of Evidence Found:

BLM Iron post with Brass cap.
 Orig. 10" now 12" D-Fir stump N44E-28 lks. nearly rotted away no marks remain.
 Orig. 12" now 24" sawed D-Fir stump S62 -35 lks. healed blaze.
 Orig. 7" now 14" sawed Hemlock stump S81½W-26 lks. opened blaze- scribing burned away.
 Orig. 10" now 20" sawed Hemlock stump N71W-27 lks. healed blaze.
 Brooks 19" now 20" sawed D-Fir stump N50E-34½ lks. healed blaze.

New Bearing Trees:

5" Cedar N42W, 28.5 ft. with lower blaze only scribed BT and with a 3/4" Brass disk stamped PLS 16337.
 16" Cedar N32E, 83.6 ft. scribed T7NR/ES6 upper blaze and a lower blaze scribed BT and with a 3/4" Brass disk stamped PLS 16337.
 Set guard post West with sign 54.4 only.
 Nailed 54.4 and BT signs to BT's and painted band and blazes red.
