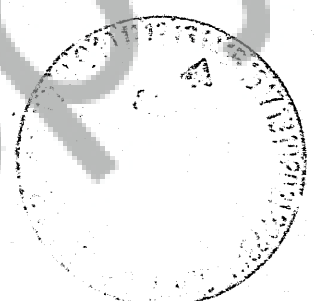

Set concrete post with Brass cap.
Scribed 24" Fir N60 E-19 1/2 lks..
32" Fir S55 E-64 lks..

BIM 4x4 concrete post with Brass cap.
Orig. 20" now 32" Hemlock S67 W-23 lks. healed blaze.
Orig. 20" now 32" D-Fir snag N52 W-36 lks. healed blaze.
Brooks 32" now 38" D-Fir S55 E-64 lks. healed blaze.
Brooks 24" now 27" D-Fir N60 E-19 1/2 lks.-healed blaze.
Unrecorded now 20" Cedar S76 E-38.1 ft. scribing visible on nearly healed blaze.

7" Hemlock N41. 34.2 ft. scribed T7NR6ES2 upper blaze and a lower blaze scribed BT and with a 3, 4" Brass disk stamped PLS 16337.
Nailed 54-4 and BT signs to BT's and painted band and blazes red.
Set guard post North with sign 54-4 only.
