NOTICE OF CLAIM OF LIEN

NOTICE IS HEREBY GIVEN, that DON KELLY d/b/a DON KELLY CONTRACT CUTTING, of Astoria, Clatsop County, State of Oregon, claims a lien upon logs, being approximately 3,794,671 board feet in quantity, which were cut or manufactured in Skamania County, State of Washington, taken from Section 28, Township 7 North, Range 6 East in said county, are marked and branded BN 28; and are now lying in the following places:

- A. RSG Forest Products, Kalama, Cowlitz County, Washington.
- B. Wall Boom, Woodland, Cowlitz County, Washington.
- C. Van Port Manufacturing, Boring, Clackamas County, Oregon.
- D. Pacific Lumber & Shipping, Longview, Cowlitz County, Washington.
- E. Rain Creek Sorting Yard, Chelatchie Prairie, Clark County, Washington.

for labor performed upon and assistance rendered in logging said logs; that the name of the owner or reputed owner is BURLINGTON NORTHERN RAILROAD who's agent is MY SON'S LOGGING, INC.; that BURLINGTON NORTHERN RAILROAD and MY SON'S LOGGING, INC., employed said DON KELLY d/b/a DON KELLY CONTRACT CUTTING to perform labor and render assistance upon the following terms and conditions, to-wit:

That said BURLINGTON NORTHERN RAILROAD and MY SON'S LOGGING, INC. agreed to pay the said DON KELLY d/b/a DON KELLY CONTRACT CUTTING for such labor and assistance \$7.50 per 1,000 board feet; that said contract has been faithfully performed and fully complied with on the part of said DON KELLY d/b/a DON KELLY CONTRACT CUTTING, who performed labor upon and assisted in logging said logs for the period of eight (8) months; that said labor and assistance were so performed and rendered upon said logs between the 1st day of December, 1981 and the 23rd day

of July, 1982; and that the rendition of said services was closed on the 23rd day of July, 1982, and that thirty (30) days have not elapsed since that time; that the amount of Claimant's demand for services is \$28,860.00, including \$400.00 additional expense incurred in bucking logs on the "Helicopter Project" and that no part thereof has been paid; there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$28,860.00 in which Claimant claims a lien upon all said logs. The said DON KELLY d/b/a DON KELLY CONTRACT CUTTING also claims a lien on all said logs owned by said BURLINGTON NORTHERN RAILROAD and MY SON'S LOGGING, INC. of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
