for labor performed upon and assistance rendered in hauling said logs; that the name of the owner or reputed owner is Burlington Northern Railroad (B/N) who's agent is my Son's Logging, Inc., that B/N and My Son's Logging, Inc., employed said Settlemier Trucking Inc., to perform such labor and render such assistance upon the following terms and conditions, to wit;

The said B/N and My Son's Logging, Inc., agreed to pay the said Settlemier Trucking, Inc., for such labor and assistance that said contract has been faithfully performed and fully complied with on the part of said Settlemier Trucking Inc., who performed labor upon and assisted in hauling said logs for the period of 12 weeks; that said labor and assistance were so performed and rendered upon said logs between the 3rd day of May, 1982, and the 23rd day of July 1982; and the rendition of said service was closed on the 23rd day of July, 1982, and thirty days have not elapsed since that time; that the amount

of claimant's demand for said service is \$34,933.59 that no part thereof has been paid except \$11,072.00 and there is now due and remaining unpaid thereon after deducting all just credits and offsets, the sum of \$23,261.50 in which he claims a lien upon all said logs. The said Settlemier Trucking Inc. also claims a lien on all said logs now owned by said S/N and My Son's Logging Inc. of said County to secure payment for the work and labor performed in obtaining or securing the said logs, spurs, piles or other timber, lumber or shingles herein described.

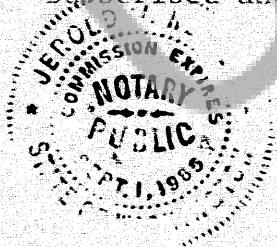
