for labor performed upon and assistance rendered as a shovel operator, for shovel rental, and for rental on pick-up truck; that the name of the owner or reputed owner is Burlington Northern Railroad (B/N) whose agent is My Son's Log, Inc., that B/N and My Son's Log, Inc., employed said Edward Paul to perform such labor and render such assistance upon the following terms and conditions, to wit:

The said B/N and My Son's Log, Inc., agreed to pay the said Edward Paul for such labor and assistance as follows: pick-up truck rental for ^{Thirty One} three days for a sum of \$372.00, shovel and crew for three days for sum of \$1,200.00, and wages as shovel operator in the amount of \$1,143.00 for a total of \$2,715.00; that said contract has been faithfully performed and fully complied with on the part of said Edward Paul, who performed labor upon and assisted as listed above, for the period of two months; that said labor and assistance were so performed and rendered upon said logs between the 1st day of June, 1982, and the 23rd day of July, 1982, and the rendition of service was closed on the 23rd day of July, 1982 and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$2,715.00; that no part thereof has been paid; and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$2,715.00 in which he claims a lien upon said logs. The said Edward Paul also claims a

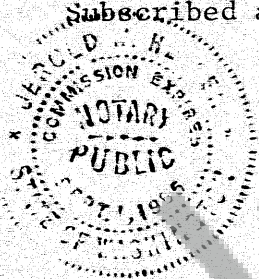
