- E. Rain Creek Sorting Yard, Chelatchie Prairie, Clark Co., Washington


for labor performed upon and assistance rendered in providing gas, grease, oil, transmission fluid, batteries, and labor on logging trucks and equipment; that the name of the owner or reputed owner is Burlington Northern Railroad (B/N) whose agent is My Son's Log, Inc., that B/N and My Son's Log, Inc., employed said Woodland Auto Supply, Inc., to perform such labor and render such assistance upon the following terms and conditions, to wit:

The said B/N and My Son's Log, Inc., agreed to pay the said Woodland Auto Supply, Inc. for such labor and assistance \$1,459.20; that said contract has been faithfully performed and fully complied with on the part of said Woodland Auto Supply, Inc., who performed labor upon and assisted in providing the necessary maintenance and operating supplies for hauling said logs, for the period of two months; that said labor and assistance were so performed and rendered upon said logs between the 3rd day of June, 1982, and the 28th day of July, 1982, and the rendition of service was closed on the 28th day of July, 1982 and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$1,459.20; that no part thereof has been paid; and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the

sum of \$1,459.20 in which Woodland Auto Supply, Inc. claims a lien upon said logs. The said Woodland Auto Supply, Inc. also claims a lien on all logs now owned by said B/N and My Son's Log, Inc., of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.


