1. History of Corner Establishment and Subsequent Restoration:

Originally set by John Truten during 1857 G.L.O. survey. Restored in 1908 with Skamania County iron pipe and cap. County records indicate that 2 B.T. snags were found during 1908 survey. Pipe used in 1971 unrecorded Dept. of Game survey and 1979 Alpha Engineers survey filed in Book 10 page 199.

2. Description of Evidence Found:

Above mentioned Skamania County iron pipe and cap set in a monument case 3" below surface of Alder Road, 63.8 ft south of centerline of Buhman Road and 34.6 ft West of Line Crossing Post. Held for corner.
 Accepted corner.
