2. Description of Evidence Found:

Basalt stone 22"x8"x14" marked 2 HES 193 on Southeast face-buried 30" in fill-left in place and set monument on top of stone.

Orig. 8" now 12" Yew S3-45W-36 lks.-opened 4" long portion of indistinct blaze-heart rotted away. No scribing found.
