 Nailed 54-4 and 54-3 to all BT's.



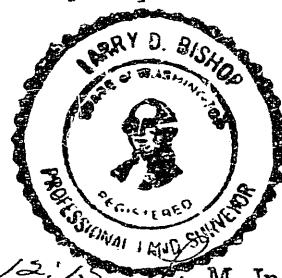
