## 1. History of Corner Establishment and Subsequent Restoration: 2. Description of Evidence Found:

GLO in 1875 set a post for this corner, from which bear:

8" dogwood, N68E, 8 links (5.28 ft.) 30" fir, N65W, 13 links (8.58 ft.)

6" fir, S50W, 34 links (22.44 ft.) 10" fir, S55E, 32 links (21.12 ft.)

DNR in 1963 found the S.3 BT and set a concrete monument, from which bear:

20" grand fir snag, S55E, 21.12 ft.

12" D-fir, S9°30'W, 15.65 ft., scribed R.B.T.

Both trees marked with DNR witness tags.

2. Found monument as described, in a mound of stone, from which:

20" grand fir, dead &amp; down and badly rotted, with "National Forest" sign

14" D-fir with healed face and DNR witness tag

A fenceline runs south and east from this corner.



## 3. Describe Monument, Accessories and Corollary Data to Perpetuate this Corner Location. Diagram corner and indicate meridian and reference to map of record.

From the 4x4 concrete monument, set 18" in the ground, in a 12x12x6" mound of stone, bear:

14" D-fir, S12W, 17.18 to center of tree with healed face and DNR witness tag

20" grand fir windfall, S53E, 22.11 ft. to center of rotted remains

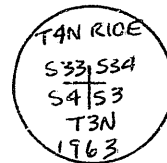
14" white fir, N29W, 59.00 ft. to center of tree scribed on root crown S33WT

18" D-fir, N25E, 63.19 ft. to center of tree scribed on root crown S34WT

16" D-fir, S7E, 26.45 ft. to center of tree scribed on root crown S3WT

New witness trees marked with aluminum witness tags.

Corner is 25 ft. south of centerline of a gas line.
