Notice is hereby given that CLYDE H. (Road 2500) in Skamania County, State of Washington, are not marked, and are now lying in Longview, Washington at Longview Fibre Company Mill, for labor performed upon and assistance rendered in hauling said logs; that the name of the owner or reputed owner is Dave Burrill d/b/a Dave Burrill Logging Co., Bud Wilson and Bill Walsh; that Dave Burrill d/b/a Dave Burrill Logging Co., Bud Wilson and Bill Walsh employed said CLYDE H. Buchannan, who performed labor upon and assisted in hauling said logs for the period of approximately three (3) months; that said labor and assistance were so performed and rendered upon said logs between the 1st day of December, 1983 and the 12th day of March, 1984; and the rendition of said service was closed on the 12th day of March.
