NOTICE IS HEREBY GIVEN that Cowlitz Loggers Associ-
ation, a Washington corporation, whose registered
office and principal place of business is 155 Main
Street, Morton, Washington 98356, hereby claims a
lien upon 2,299,380 board feet of logs derived from
timber removed from douglas fir, white fir and hemlock
saw logs, utility (chip) logs and peelers in the quan-
tities hereafter stated cut and removed from real
property, the subject of the "Dry Johnson" Timber Sale
located in Sections 1, 2, 11 and 12, Township 12 North,
Range 9 East, W.M., Lewis County, Washington, and that
portion in Unit 1, Section 5, Township 11 North, Range 6
East, W.M., Skamania County, Washington, the subject of the
"Polar" Timber Sale. Said logs are now lying in the
following quantities at Brazier Forest Products, Inc.,
or Forest Products Industries, Inc., or Brazier Forest
Products of Oregon, Inc. Fredrickson yard in Graham,
Pierce County, Washington (470,900 ft.), and its mill yard
in Arlington, Snohomish County, Washington (9,800 ft.);
and Portac Forest Products, Inc.'s yard at 4215 East West
Road, Tacoma, Pierce County, Washington (330,140 ft.); or

Lewis County, Washington (108,230 ft.); and Fort Vancouver Plywood at its mill at the foot of W. 8th Street, Vancouver, Clark County, Washington (1,380,810 ft.).

Said claim of lien is for scaling services performed in the furnishing of the location and facilities necessary to the actual scaling performed by the Columbia River Scaling Bureau and for assistance rendered in the obtaining of said logs hereby liened against and delivered to the parties above named. The amount agreed to be paid to claimant by Brazier Forest Products, Inc., Brazier Forest Industries, Inc. and Brazier Forest Products of Oregon, Inc. for said services is the sum of \$1.00/mbf of logs scaled at the facilities furnished by claimant.

That said contract has been faithfully performed and fully complied with by claimant.

That the rendition of said services commenced January 23, 1984 and terminated on August 3, 1984. That the value of the services performed by claimant during said period and the amount agreed to be paid therefor is the sum of \$10,762.64, of which \$6,100.27 has been paid, leaving the sum of \$4,662.37, for which amount this lien is claimed.

Claimant further claims a lien of \$250 attorney fees for the preparation of this lien and \$40 for the estimated costs of recording the same.
