Noel for and on behalf of said owners employed the said R.N.Bennett to perform such labor and render such assistance upon the following terms and conditions, towit: The said owners employed this claimant as such chaser at theagreed wage of \$4.50 per day; that said contract has been faithfully performed and fully complied with on the part of this claimant, who performed such labor and rendered such assistance for the period from September 24,1917, to November 10, 1917, inclusive, and the rendition of said services was closed on the 10th day of November, 1917, and thirty days have not elapsed since that time; that the amount of claimant's demand for such services is \$49.65; that no part of said claim has been paid and there is now due and remaining unpaid thereon the sum of \$49.65, after deducting all just credits and offisets, in which amount he claims a lien upon the timber products above described. The said claimant also claims a lien upon all lumber, ties and timber products now owned by said owners in said county to secure payment for the work and labor of securing the said ties, timber, lumber and timber products.
