

Notice of Location "Lulu" Mining Claim

Notice of Location.
 "Lulu" Lode Mining Claim.
 Copper Creek Mining District.
 Okanania County, State of Washington.

The undersigned, who is a citizen of the United States, hereby declare and give notice to all persons concerned, that he has discovered a Vein or Lode within the limits of the claim hereby located, and in said lode a vein & crevice of quartz or ore, with at least one well-defined wall, and that he has this seventh day of February A. D. 1899, located and do hereby locate and claim, under and by virtue of Chapter Six, Title Thirty-two, of the Revised Statutes of the United States, and the laws amendatory thereto, and the laws of the State of Washington, a mining claim upon said lode or vein, to be designated and named the "Lulu" Quartz Lode Mining Claim, extending along said lode or vein 1500 feet in an Easterly direction from the center of the Discovery shaft (at which shaft this notice and statement is posted), and 300 feet on each side from the middle or center of said Lode or Vein at the surface, comprising in all 1500 feet in length along said Lode or Vein, and 600 feet in width, with all the rights and privileges, as to surface ground and lodes, veins or ledges, within the boundaries of said claim and otherwise, and the metals, minerals and valuable deposits of every kind contained in said veins, lodes or ledges, or within said boundaries, which are given or allowed by the laws of the United States aforesaid, or of the State of Washington.

The Mining Claim hereby located is situated in Copper Creek Mining District Okanania County, Washington, and is situated on a small stream emptying into Copper Creek on East side, near the line running S. 7. W. Sec. 35 & 45. T. 11. N.

Beginning at Prospect hole where this notice is posted, and running thence northerly 300 ft. to post marked at Nth West cor. of "Lulu" claim. Thence 1500 ft. in an Easterly direction to post marked North East

cor. of Lulu claim: Thence 500 ft. in a Southerly direction to post marked East Center End post of Lulu claim: Thence 500 ft. in a Southerly direction to post marked South East cor. of Lulu claim: Thence 1500 ft.
