NOTICE OF LIEN

W.T.Noel, J.P.Noel and W.R.Bailey,
doing business under the firm name
and style of Noel-Bailey Lumber Company
and Hill Lumber Company, a corporation,
Owners.

Notice is hereby given that Louie Andreoni of Skamania Washington, claims a lien upon a quantity of lumber, ties, and timbers located and being upon the platform and in a Union Pacific System Railroad car, number 25270 at what is known as Dopp's spur, on the S.P. and S. Railroad, about $\frac{3}{4}$ miles East of Skamania Post Office in Skamania County, Washington, being about 60,000 feet in quantity, which lumber, ties and timbers were cut and manufactured in Skamania County, Washington, for labor performed upon and for assistance rendered in and about the cutting, hauling, and preparing said timber, lumber and ties for market; that the names of the owners, or reputed owners of said lumber, ties and timber are W.T.Noel, L.P.Noel and W.R.Bailey, who are doing business under the firm name and style of Noel-Bailey Lumber Company and Hill Lumber Company, a corporation; that said J.P.Noel for and on behalf of said owners employed said Louie Andreoni to perform said labor and to render said assistance and that the said J.P.Noel for and on behalf of said owners did agree to pay said Louie Andreoni for such labor and assistance the sum of \$4.00 per day for a ten hour day, handling said lumber and ties on the loading platform at said Dopp's spur. That said contract has been faithfully performed and fully complied with on the part of said Louie Andreoni, who performed labor upon and assisted in and about the cutting, hauling and preparing said lumber, timber and ties for market from the 28th day of July, 1917 to the 10th day of November, 1917. and the rendition of the said services closed on the said 10th day of November, 1917. and thirty days have not elapsed since said date. and that there is now due and owing to this claimant thereon the sum of \$153.85 after deducting all just credits and offsets. In which amount he claims a lien upon all the lumber, timber and ties, aforesaid. The said Louie Andreoni also claims a lien upon all the lumber, timber, ties and logs, timber and timber products now owned by said owners above named in Skamania County, Washington, to secure the payment of the amount due him for said work and labor performed in obtaining said logs, lumber, ties and timber products.
