NOTICE IS HEREBY GIVEN that F.N.Ridley and G.D.Ridley, as partners, of Skamania County, State of Washington, claim a lien upon a quantity of four foot and sixteen inch cordwood, being about 130 cords in quantity, which were cut or manufactured in Skamania County, State of Washington, are unmarked, and are now lying on the Charles Olien land about one half mile westward of the town of Stevenson in said county, such land being about 33 acres in Section 2, Township 2, North, of Range 7 East of the Willamette Meridian, and piled on railroad track of the S.P.&S. about 150 yards eastward of the depot in said town of Stevenson, for labor performed and assistance rendered in and about cutting, hauling, splitting and obtaining said cordwood for market, that the name of the owner, or reputed owner, is F.H.Hapgood and Smythe & Lonergan; that F.H.Hapgood employed said F.N.Ridley and G.D.Ridley to perform such labor and render such assistance upon the following terms and conditions to-wit: The said F.H.Hapgood agreed to pay the said F.N.Ridley and G.D.Ridley the sum of \$1.00 per cord for splitting said wood, that said contract has been faithfully performed and fully complied with on the part of said F.N.Ridley and G.D.Ridley who performed labor and rendered assistance in and about lifting said cordwood for the period between the 7th day of November, 1917, and the 28th day of November, 1917, and the rendition of said of said services was closed on the 27th day of November, 1917, and thirty days have not elapsed since that time, that the amount of the claimants' demand for said service is \$55.00; that no part thereof has been paid and there is now due and remaining unpaid thereon the sum of \$55.00 in which amount they claim a lien upon said described cordwood, The said F.N.Ridley and G.D.Ridley also claim a lien upon all the wood of said owner in said county to secure payment for the labor in securing said cordwood.
