NOTICE IS HEREBY GIVEN that E.F. Stevenson, of Cape Horn, Washington, claims a lien upon a quantity of 7x8 and 7x9 railroad ties, 996 in number, which were cut or manufactured in Skamania County, Washington, are unmarked and are now situated and lying on an along the right-of-way of the S.P.&S. Railroad at Prindle Station, in said Skamania County, Washington, for labor performed upon and assistance rendered in and about the cutting, hauling and preparing said railroad ties for market; that the names of the owners or reputed owners of said ties and of the mill and logging camp where same were cut and ^{where} the work of claimant was performed as herein stated are, Al Iman, George Iman and Columbus Field, doing business under the firm name and style of Iman Lumber Company and that Al Iman, employed said E.F. Stevenson, for such labor and assistance upon the following terms and conditions, to-wit:- at \$8.50 per day of eight hours, running and operating a donkey engine, that said contract has been faithfully performed and fully complied with on the part of the claimant, E.F. Stevenson, who under said contract of employment performed labor upon and rendered assistance in and about the cutting, hauling and preparing said ties for market for a period of 31½ days, between the 1st day of April, 1918 and the 22nd day of June, 1918, and the rendition of said services closed on the 22nd day of June, 1918 and thirty days have not elapsed since said date; that no part of the payment for said services has been paid, and there is now due and owing from the said Al Iman, George Iman and Columbus Field to this claimant thereof, after deducting all just credits and offsets, the sum of \$257.74 in which amount he claims a lien upon all said ties hereinabove described and all other timber, ties, lumber and lumber products now owned by said owners above named in said County of Skamania, to secure payment for the rendition of said services, to-wit: the work and labor performed assisting in obtaining cutting, hauling and
