Stone & John Doe Vanderberg, said mill being lecated on leased land on the southeast quarter of section 23, Township 2 North Range 6 East, Weillamette meridian; also on one certain lot of lumber, consisting of about 30,000 feet of mixed lumber, and a lumber dock, located in the southwest quarter of Section 24, Township 2 North Range 6 East of the willamette Meridian. Also on one certain steam logging donkey engine, together with the lines, chockers and hooks, blocks, and all other logging equipment and apparatus belonging thereto and situated on and about the above described premises. The said contract has been faithfully performed and fully complied with on the part of H.R. acribner, who performed labor upon and assisted in the handling and securing of logs and the manufacture of lumber in and about the aforesaid parties' mill, for. 1472. hours. That said labor and assistance and services were performed and rendered upon said logs and lumber between the 25th. day of Juny, 1918 and the 17th day of July, 1918, and the rendition of said service was closed on the .17th day of July, 1918, and the amount of claimants demand for said services is \$101.85.... That no part thereof has been paid and thereis now due and in paid thereon, after deducting all just credits, the sum of \$101.85. in which amount this claimant claims a lien on all of the parturers, above and foregoing described real and personal property or any interest the Mt Hood Lumber Company or J.L.
