NOTICE IS HEREBY GIVEN that B. E. COPPLER, of Portland, Multnomah County, Oregon, claims a lien on the franchise, earnings, and on all the real and personal property owned by and used in the operation of the sawmill of the Mt. Hood Lumber Company, J. L. Weist, L.C. Stone, and John Doe Vanderberg, particularly located and described as follows:

On said sawmill and all the equipment, tools, lumber trucks, machinery, belts, pulleys, and buildings and on all the lumber around and about said mill belonging to the said Mt. Hood Lumber Company, J. L. Weist, L. C. Stone and John Doe Vanderberg, said mill being located on leased land in the southeast quarter of Section 23, township 2, North Range 6, East Willamette Meridian; also on one certain lot of lumber, consisting of about 1000 railroad ties, about 15,000 feet of scantling, about 30,000 feet of mixed lumber, and a lumber dock, situated in the southwest quarter of Section 24, township 2, North Range 6, East of the Willamette Meridian. Also on one certain steam logging donkey engine, together with the lines, chokers, hooks, blocks, and all other logging equipment and apparatus belonging thereto and situated on and about the above described premises. And also on one and one half miles of flume situated on the aforesaid described premises. And also on one gasoline dragsaw and equipment situated on the aforesaid described premises.

That said Mt. Hood Lumber Company, J. L. Weist, L. C. Stone, and John Doe Vanderberg, agreed to pay this claimant, B. E. Coppler, the sum of .65 per hour, for 113 hours, for his services as laborer, more particularly described as that of an off-bearer, in the manufacture of lumber.

The said contract has been faithfully performed and fully complied with on the part of the said B. E. Coppler, who performed labor upon and assisted in the handling of logs and the manufacture of lumber in and about the aforesaid party's mill for 113 hours, at the rate of .65 per hour. That said labor and assistance and services were performed and rendered upon said lumber between the 26th day of June, 1918, and the 17th day of July, 1918, and the rendition of said services was closed on the 17th day of July, 1918; and the amount of claimant's demand for services is \$73.45. That no part thereof has been paid, and that there is now due and unpaid thereon, after deducting all just credits, the sum of \$73.45, in which amount this claimant claims a lien on all of the above and foregoing described real and personal property or any interest, the Mt. Hood Lumber Company, J. L. Weist, L. C. Stone, or John Doe Vanderberg may have in said real and personal property, to secure payment for work and labor and services performed as herein described. Said work and labor having been performed within 90 days last past.
