NOTICE IS HEREBY GIVEN that Quincy Wade, of Carson, Skamania County, Washington, claims a Lien upon the franchise, earnings and all the real and personal property of the owners above named, to-wit: the said Carson Lumber Company, which franchise, earnings and real and personal property were and are used in the operation of the sawmill of said owners, to the full extent of all moneys due him from said owners for labor performed within six months next preceding the filing of this claim therefor, as follows:

The demand which is made by the said Quincy Wade from the said owners is for the sum of \$82.65, after deducting all just credits and offsets; the name of the person employing this claimant and who acted for and on behalf of said owners is Hans Berge, and the terms and conditions of said employment were that the claimant, Quincy Wade was to perform work, labor and services for the above named company and owners in the operation of their sawmill, situated on Bear Creek about Five miles North of the Town of Carson, in the County of Skamania, State of Washington; that claimant began the work aforesaid, for the owners on or about the ____ day of January, 1919, and the date of the cessation of said services, was on the 28th day of March, 1919; that the agreed wage of said claimant for said work was \$4.60 per day; that said claim is made for the sum of money for work done between January ____ 1919, and March 28th, 1919, inclusive. The property upon which this claim is filed and the franchise and earnings thereof and all thereal and personal property of said owners upon which this Lien is filed, is situated in Skamania County, Washington, and this claim is filed for security for the work above referred to on the sawmill known

as the Carson Lumber Company mill, situated on Bear Creek about Five miles North of the Town of Carson, in the County of Skamania, State of Washington, as aforesaid, the machinery, tools and appurtenances therein or adjoining and used in connection therewith, together with all ties, lumber, lumber products and wood, located at or near said mill, and on all the earnings and on all the other real and personal property of said owners which was used in the operation of said mill and business during the period of employment of said claimant for which claim is hereby filed to the full extent of the said sum of \$82.65, which is due him from said owners.
