IN SKAMANIA COUNTY WHICH CONSISTS OF TWO ENGINES, BOILERS AND OTHER EQUIPMENT FOR AND ON ACCOUNT OF LABOR, SKILL AND MATERIAL EXPENDED UPON SAID MILL.

THAT THE NAME OF THE OWNER, OR REPUTED OWNER, IS N. C. CHRISTENSEN.
