NOTICE IS HEREBY GIVEN THAT L. F. WILLEY CLAIMS A LIEN UPON ALL THE CROPS RAISED UPON THE FARM OF JOHN SCHWINGE, DESCRIBED AS FOLLOWS, TO-WIT: N $\frac{1}{2}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ AND S $\frac{1}{2}$ S $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ SECTION 22 TOWNSHIP THREE NORTH OF RANGE 10 EAST OF THE W.M., DURING THE YEAR 1921, AND PARTICULARLY UPON THE CROP OF APPLES RAISED UPON SAID FARM ABOUT 2900 BOXES, OF WHICH APPROXIMATELY 2500 BOXES ARE NOW STORED AT THE PACKING HOUSE SITUATED UPON SAID FARM FOR LABOR PERFORMED UPON SAID CROP, AND FOR ASSISTING IN SECURING, HOUSING, SORTING, PACKING AND GRADING THE CROP OF APPLES ABOVE SPECIFIED, RAISED UPON SAID FARM DURING THE SAID YEAR 1921; THAT THE NAME OF THE OWNER, OR REPUTED OWNER IS JOHN SCHWINGE; THAT CLAIMANT WAS EMPLOYED TO PERFORM SAID LABOR AND RENDER SAID ASSISTANCE BY B. R. WILLEY, CONTRACTOR FOR THE HARVESTING AND PACKING OF SAID CROP, AND AGENT FOR THE OWNER, ABOVE STATED, UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT:

CLAIMANT TO RECEIVE THE SUM OF SEVEN CENTS PER BOX FOR PACKING APPLES, AND THE SUM OF 60 CENTS PER HOUR FOR ALL OTHER LABOR IN CONNECTION WITH THE HARVESTING OF SAID CROP;

THAT THE SAID WORK AND LABOR HAS BEEN FAITHFULLY PERFORMED, UPON THE PART OF THE CLAIMANT, WHO PERFORMED LABOR AND ASSISTED IN THE HARVESTING, HOUSING, SORTING, PACKING AND GRADING SAID APPLE CROP FOR A PERIOD OF 7 DAYS BETWEEN THE 3RD DAY OF OCTOBER 1921 AND THE 13TH DAY OF OCTOBER 1921, AND THAT THE SAID SERVICES WERE CLOSED UPON THE SAID 13TH DAY OF OCTOBER 1921 AND FORTY DAYS HAVE NOT ELAPSED SINCE THAT DATE; THAT THE AMOUNT OF CLAIMANTS DEMAND FOR SAID SERVICES IS \$23.86, AND THAT NO PART THEREOF HAS BEEN PAID, AND THERE IS NOW DUE AND REMAINING UNPAID THEREON, AFTER DEDUCTING ALL JUST CREDITS AND OFF-SETS THE SAID SUM OF \$23.86, IN WHICH AMOUNT CLAIMANT CLAIMS A LIEN UPON ALL OF SAID CROP HEREIN SPECIFIED AND DESCRIBED FOR SAID LABOR AND ASSISTANCE RENDERED IN SECURING, HARVESTING, HOUSING, GRADING, SORTING AND PACKING SAID APPLE CROP AS AFORESAID.
