## LIEN NOTICE

NOTICE IS HEREBY GIVEN THAT ON THE 15TH DAY OF AUGUST, 1921, AT THE REQUEST OF JOHN DURKIN, I, THE UNDERSIGNED, C. W. STAFFORD COMMENCED TO PERFORM LABOR AND TO FURNISH MATERIAL TO BE USED UPON THE DWELLING HOUSE <sup>SITUATED</sup> ON THAT TRACT OF LAND SITUATE LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, DESCRIBED AS

COMMENCING AT THE INTERSECTION OF THE CENTER LINE OF STRAWBERRY ROAD WITH THE CENTER LINE OF STATE HIGHWAY NO. 8 IN SECTION 36, TWP. 3 N. R. 7 E. W.M., THENCE NORTHERLY ALONG THE CENTER LINE OF SAID STRAWBERRY ROAD A DISTANCE OF 257 FEET FOR THE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE NORTHERLY ALONG THE CENTER LINE OF SAID STRAWBERRY ROAD TO THE SOUTH LINE OF STEVENSON PARK ADDITION ACCORDING TO THE PLAT THEREOF IN THE OFFICE OF THE AUDITOR OF SKAMANIA COUNTY WASHINGTON, THENCE EAST ALONG THE SOUTH LINE OF SAID STEVENSON PARK ADDITION TO THE CENTER OF VALLET CREEK; THENCE FOLLOWING THE CENTER LINE OF VALLET CREEK IN A SOUTHEASTERLY DIRECTION TO THE INTERSECTION WITH THE CENTER LINE OF STATE ROAD NO. 8; THENCE FOLLOWING THE CENTER LINE OF STATE ROAD NO. 8 IN A SOUTHERLY DIRECTION TO A POINT 356 FEET DISTANT FROM THE INTERSECTION WITH STRAWBERRY ROAD (MEASURED FROM SAID POINT OF INTERSECTION EASTERLY ALONG THE CENTER LINE OF SAID STATE ROAD NO. 8); THENCE IN A STRAIGHT LINE IN A WESTERLY DIRECTION TO THE POINT OF BEGINNING, CONTAINING 3 ACRES, MORE OR LESS
