DOUGLAS, OF COOKS, SKAMANIA COUNTY, WASHINGTON, CLAIMS A LIEN UPON A QUANTITY OF SLAB WOOD BEING ABOUT 65 CORDS, WHICH WERE CUT AND MANUFACTURED IN SKAMANIA COUNTY, WASHINGTON, AND ARE NOW LYING AND BEING AT COOKS ON THE BOAT LANDING AND ON THE RIGHT OF WAY OF THE S.P. & S. RY CO, AT COOKS, ON SPOW AT COOKS AND WOOD CAR ON S.P. & S. SPUR AT COOKS

FOR LABOR PERFORMED IN HAULING AND TRANSPORTING AND PILING THE SAME; THAT THE NAME OF THE OWNER OR REPUTED OWNER IS C. F. ARMSTRONG AND T. D. WEAVER, AND THAT HE EMPLOYED CLAIMANT TO PERFORM THE SAID LABOR AND SERVICES AND TO RENDER SUCH ASSISTANCE IN HAULING, TRANSPORTING AND PILING THE SAID SLAB-WOOD UPON THE FOLLOWING CONDITIONS, TO-WIT:

HAULING 151 CORDS OF WOOD AT THE RATE OF \$1.40 PER CORD

THAT CLAIMANT RENDERED THE SAID SERVICES ACCORDING TO HIS AGREEMENT, AND PERFORMED THE SAID LABOR DURING A PERIOD OF 63 DAYS COMMENCING SEPT 1ST 1921 AND ENDING NOVEMBER 3RD 1921 AND THAT SAID SERVICES WERE CLOSED ON TH- NOVEMBER 3RD 1921 AND THAT THIRTY DAYS HAVE NOT ELAPSED SINCE THE DATE OF THE CLOSING OF SAID SERVICES; THAT THE AMOUNT OF CLAIMANTS DEMAND FOR SAID SERVICE IS \$211.40 AND THERE IS DUE AND OWING TO CLAIMANT FROM THE SAID OWNER THE SUM OF \$211.00 OVER AND ABOVE ALL JUST CREDITS AND OFFSETS, IN WHICH AMOUNT HE CLAIMS A LIEN UPON THE SAID SLAB-WOOD. THE CLAIMANT ALSO CLAIMS A LIEN UPON ALL SLAB-WOOD OWNED BY THE SAID OWNER TO SECURE PAYMENT FOR THE WORK AND LABOR PERFORMED IN OBTAINING, TRANSPORTING AND HAULING AND PILING THE SAID SLAB-WOOD HEREIN DESCRIBED.
