NOTICE IS HEREBY GIVEN THAT B. R. WILLEY CLAIMS A LIEN UPON THE ORCHARD AND ORCHARD LANDS BELONGING TO JOHN SCHWINGE, AND DESCRIBED AS FOLLOWS, TO-WIT:

N $\frac{1}{2}$ OF SE $\frac{1}{4}$ OF NE $\frac{1}{4}$ AND THE S $\frac{1}{2}$ OF NE $\frac{1}{4}$ OF NE $\frac{1}{4}$, SECTION 22, TOWNSHIP 3, NORTH RANGE 10 EAST OF WILLAMETTE MERIDIAN, AND PARTICULARLY UPON THE CROP OF APPLES RAISED UPON SAID LANDS, BEING ABOUT 2900 BOXES, OF WHICH APPROXIMATELY 2500 BOXES ARE NOW STORED UPON SAID LAND, IN A PACKING HOUSE SITUATED THEREON, FOR LABOR PERFORMED UPON SAID CROP OF APPLES, AND FOR ASSISTING IN SECURING, HOUSING, SORTING, PACKING AND GRADING SAID APPLES, AND FOR REPAIRING APPLE-PACKING HOUSE AND APPLE-GRADER IN SAID APPLE-PACKING HOUSE SITUATE ON SAID LAND, SAID CROP OF APPLES BEING RAISED ON SAID LAND DURING THE YEAR 1921; THAT THE NAME OF THE OWNER OR REPUTED OWNER OF SAID APPLE CROP AND LAND IS JOHN SCHWINGE; THAT CLAIMANT WAS EMPLOYED TO PERFORM SAID LABOR AND RENDER ASSISTANCE BY THE SAID JOHN SCHWINGE; THAT SAID LABOR WAS REASONABLY WORTH \$1.00 PER HOUR; THAT SAID LABOR HAS BEEN FAITHFULLY PERFORMED UPON THE PART OF THE CLAIMANT, WHO PERFORMED LABOR AND ASSISTED IN HARVESTING, HOUSING, SORTING, PACKING AND GRADING SAID APPLE CROP, FOR A PERIOD OF 124 $\frac{1}{2}$ HOURS; SAID LABOR BEGAN ON THE 22ND DAY OF SEPTEMBER, AND ENDED ON THE 13TH DAY OF OCTOBER, 1921; THAT SAID SERVICES WERE CLOSED ON THE SAID 13TH DAY OF OCTOBER, 1921 AND FORTY DAYS HAVE NOT ELAPSED SINCE THAT DATE; THAT THE AMOUNT OF CLAIMANT'S DEMAND IS \$124.50, AND NO PART THEREOF HAS BEEN PAID, AND THERE IS NOW DUE AND REMAINING UNPAID THEREOF, AFTER DEDUCTING ALL JUST CREDITS AND OFF-SETS THE SAID SUM OF \$124.50, IN WHICH AMOUNT CLAIMANT CLAIMS A LIEN UPON ALL OF SAID APPLE CROP HEREIN SPECIFIED AND UPON THE LAND HEREIN DESCRIBED, FOR SAID LABOR AND ASSISTANCE RENDERED IN SECURING, HARVESTING, HOUSING, PACKING SORTING AND GRADING SAID APPLES, AND FOR REPAIRING SAID APPLE-PACKING HOUSE AND APPLE-GRADER LOCATED IN SAID PREMISES AFORESAID.
