NOTICE IS HEREBY GIVEN THAT B. M. BROWN CLAIMS A LIEN UPON A QUANTITY OF ROUGH LUMBER AND TIMBER, BEING ABOUT 273,495 FEET BOARD MEASURE IN QUANTITY, WHICH WAS CUT AND MANUFACTURED IN SKAMANIA COUNTY, STATE OF WASHINGTON, AND IS NOW LYING AND PILED ON THE LUMBER DOCK AND IN THE LUMBER YARD AT THE END OF FLUME OF THE GRAND FLUME AND LUMBER COMPANY; AT HOOD IN SAID COUNTY AND STATE, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN CUTTING AND MANUFACTURING SAID LUMBER AND TIMBER; THAT THE NAME OF THE OWNER, OR REPUTED OWNER, IS DOUGLAS LUMBER COMPANY, AND H. D. DOUGLAS; THAT SAID DOUGLAS LUMBER COMPANY, AND H. D. DOUGLAS, EMPLOYED CLAIMANT TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT:

THAT SAID DOUGLAS LUMBER COMPANY AND H. D. DOUGLAS AGREED TO PAY CLAIMANT FOR SUCH LABOR AND ASSISTANCE THE SUM OF \$5.00 PER DAY FOR SAID LABOR AND ASSISTANCE; THAT SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND FULLY COMPLIED WITH ON THE PART OF SAID CLAIMANT, WHO PERFORMED LABOR UPON AND ASSISTED IN THE CUTTING AND MANUFACTURING OF SAID LUMBER AND TIMBER FOR THE PERIOD OF 48 DAYS (INCLUDING OVER TIME), THAT SAID LABOR AND ASSISTANCE WERE SO RENDERED AND PERFORMED UPON THE CUTTING AND MANUFACTURE OF SAID LUMBER AND TIMBER, BETWEEN THE 1ST DAY OF AUGUST 1922 AND THE 16TH DAY OF SEPTEMBER 1922, AND THE RENDERING OF SAID SERVICES WAS CLOSED ON THE 16TH DAY OF SEPTEMBER 1922, AND THIRTY DAYS HAVE NOT ELAPSED SINCE THAT TIME; THAT THE AMOUNT OF CLAIMANT'S DEMAND FOR SAID SERVICES IS THE SUM OF \$240.00 AND \$22.00 ADVANCED FOR LABOR AND REPAIR ON CAR, AND THAT NO PART THEREOF HAS BEEN PAID EXCEPT \$1.50, AND THERE IS DUE AND REMAINING UNPAID THEREON, AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS, THE SUM OF \$260.50 IN WHICH AMOUNT HE CLAIMS A LIEN ON ALL SAID LUMBER AND TIMBER. THE SAID CLAIMANT ALSO CLAIMS A LIEN ON ALL SAID LUMBER AND TIMBER NOW OWNED BY SAID DOUGLAS LUMBER COMPANY AND H. D. DOUGLAS IN SAID COUNTY TO SECURE PAYMENT FOR THE WORK AND LABOR PERFORMED IN OBTAINING OR SECURING THE SAID LUMBER AND TIMBER HEREIN DESCRIBED.
