NOTICE IS HEREBY GIVEN THAT B. F. MCCUTCHEON OF SKAMANIA COUNTY, WASHINGTON CLAIMS A LIEN UPON A LOT OF APPLES, BEING ABOUT 278 BOXES IN QUANTITY WHICH WERE GRADED AND PACKED IN SKAMANIA COUNTY, WASHINGTON, ARE MARKED W. F. CASH, GROWER AND 243 BOXES OF SAID APPLES ARE NOW LYING ON THE PROPERTY OF W. F. CASH ON THE SE. $\frac{1}{4}$ OF SEC. 15, TWP. 2, N. R. 10 E. W.M. AND 35 BOXES OF SAID APPLES IN THE WARE HOUSE OF UNDERWOOD GROWERS ASSOCIATION AT UNDERWOOD, WASHINGTON, FOR LABO. PERFORMED UPON AND ASSISTANCE RENDERED IN GRADING AND PACKING SAID APPLES; THAT THE NAME OF THE OWNER OR OF SAID APPLES REPUTED OWNER IS W. F. CASH; THAT HE EMPLOYED SAID CLAIMANT TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT:

THAT THE SAID W. F.
