NOTICE OF LIEN.

NOTICE IS HEREBY GIVEN THAT GEORGE W. FISHER OF SKAMANIA COUNTY, WASHINGTON, CLAIMS A LIEN UPON A QUANTITY OF LUMBER, BEING ABOUT 30000 FEET ON DOCK AT S. P. & S. R. AT COOK, SAID COUNTY AND STATE AND ABOUT 50000 AT MILL OF SAID DEFENDANT LOCATED ABOUT 2½ MILES NORTH OF COOK, SAID COUNTY AND STATE, WHICH WAS CUT AND MANUFACTURED IN SAID COUNTY AND STATE, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN MANUFACTURING SAID LUMBER; THAT THE NAME OF THE OWNER OR REPUTED OWNER IS DOUGLASS LUMBER COMPANY AND A. L. DOUGLASS; THAT SAID A. L. DOUGLASS EMPLOYED THE SAID GEORGE W. FISHER TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT:

THE SAID A. L. DOUGLASS AGREED TO PAY THE SAID GEORGE W. FISHER FOR SUCH LABOR AND ASSISTANCE; THAT SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND FULLY COMPLIED WITH ON THE PART OF SAID GEORGE W. FISHER WHO PERFORMED LABOR UPON AND ASSISTED IN THE MANUFACTURING OF SAID LUMBER FOR THE PERIOD OF 30 DAYS; THAT SAID LABOR AND ASSISTANCE WERE SO PERFORMED AND RENDERED UPON SAID LUMBER BETWEEN JULY 9TH, 1923 AND AUGUST 12TH 1923; AND THE RENDITION OF SAID SERVICES WAS CLOSED ON THE 11TH DAY OF AUGUST, 1923 AND THIRTY DAYS HAVE NOT ELAPSED SINCE THAT TIME; THAT THE AMOUNT OF CLAIMANTS DEMAND FOR SAID SERVICES IS \$150.00; THAT NO PART THEREOF HAS BEEN PAID EXCEPT THE SUM OF \$8.05, AND THERE IS NOW DUE AND REMAINING THEREON AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS, THE SUM OF \$141.95 IN WHICH AMOUNT HE CLAIMS A LIEN UPON SAID LUMBER. THE SAID GEORGE W. FISHER ALSO CLAIMS A LIEN ON ALL SAID LUMBER NOW OWNED BY SAID DOUGLASS LUMBER COMPANY AND A. L. DOUGLASS OF SAID COUNTY TO SECURE PAYMENT FOR THE WORK AND LABOR PERFORMED IN THE MANUFACTURE OF SAID LUMBER HEREIN DESCRIBED.
