NOTICE IS HEREBY GIVEN THAT HAROLD AALVIK BY CHRIS AALVIK OF SKAMANIA COUNTY, STATE OF WASHINGTON, CLAIMS A LIEN UPON A QUANTITY OF LUMBER AND SLAB WOOD, BEING ABOUT THIRTY THOUSAND FEET OF LUMBER AT THE MILL AND ABOUT FIFTY THOUSAND FEET OF LUMBER ON AND AROUND THE LOADING PLATFORM AT COOK STATION, AND ABOUT 1000 CORDS OF SLAB WOOD AT THE MILL, SAID MILL BEING LOCATED ABOUT THREE AND ONE-HALF MILES NORTH OF COOK AND ABOUT ONE HALF MILE WEST OF THE MAIN HIGHWAY, WHICH SAID LUMBER AND SLAB WOOD WAS CUT OR MANUFACTURED IN SKAMANIA COUNTY, WASHINGTON, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN THE MANUFACTURE OF SAID LUMBER AND SLAB WOOD; THAT THE NAME OF THE OWNER OR REPUTED OWNER IS A. L. DOUGLASS LUMBER COMPANY; THAT SAID A. L. DOUGLASS EMPLOYED SAID HAROLD AALVIK TO PERFORM SUCH LABOR AND RENDER SUCH ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS TO-WIT:

THE SAID A. L. DOUGLASS AGREED TO PAY THE SAID HAROLD AALVIK FOR SUCH LABOR AND ASSISTANCE; THAT SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND FULLY COMPLIED WITH ON THE PART OF THE SAID HAROLD AALVIK WHO PERFORMED LABOR UPON AND ASSISTED IN THE SAID MANUFACTURING FOR THE PERIOD OF FROM 19 JUNE, 1923 TO AUGUST 4, 1923; THAT SAID LABOR AND ASSISTANCE WERE SO PERFORMED AND RENDERED UPON SAID LUMBER BETWEEN THE 18TH DAY OF JUNE, 1923 AND THE 5TH DAY OF AUGUST, 1923; AND THE RENDITION OF SAID SERVICES WAS CLOSED ON THE 4TH DAY OF AUGUST, 1923 AND 30 DAYS HAVE NOT ELAPSED SINCE THAT TIME; THAT THE AMOUNT OF CLAIMANTS DEMAND FOR SAID SERVICE IS \$328.00 THAT NO PART THEREOF HAS BEEN PAID EXCEPT \$225.00 AND THERE IS NOW DUE AND REMAINING UNPAID THEREON, AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS, THE SUM OF \$98.00 IN WHICH AMOUNT HE CLAIMS A LIEN ON ALL SAID LUMBER AND SLAB WOOD NOW OWNED BY SAID A. L. DOUGLASS LUMBER COMPANY OF SAID COUNTY TO SECURE PAYMENT FOR THE WORK AND LABOR PERFORMED IN OBTAINING OR SECURING THE SAID LOGS, SPARS, PILES OR OTHER TIMBER, LUMBER OR SHINGLES HEREIN DESCRIBED.
