CRAYON WITH THE INITIALS A.C. AND WITH NUMBER OF RICKS IN EACH PILE AND ARE NOW  
LYING ON A TRACT OF LAND ABOUT  $\frac{1}{4}$  MILE NORTH AND  $\frac{1}{4}$  MILE WEST OF THE LOWER SCHOOL  
HOUSE OF SCHOOL DIST. 18 IN SKAMANIA COUNTY WASHINGTON AND WEST AND SOUTH OF THE

QUANTITY OF WOOD THAT WAS CUT. THAT SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND  
FULLY COMPLIED WITH ON THE PART OF SAID ALEX CARPENTER WHO PERFORMED SAID LABOR  
IN CUTTING SAID WOOD. THAT SAID LABOR WAS PERFORMED AND RENDERED UPON SAID WOOD  
BETWEEN THE FIRST DAY OF SEPTEMBER 1924 AND THE 10TH DAY OF JANUARY 1925 AND THE
