SPEER, CLAIMS TO HAVE BEEN EMPLOYED BY THE CARSON MILL & FLUME COMPANY FOR THE PERIOD FROM ABOUT JANUARY 1, 1925 TO APRIL 1, 1925 AT THE AGREED SALARY OF \$200.00 PER MONTH AND THAT HE CLAIMS STILL DUE HIM ON ACCOUNT OF SUCH LABOR THE SUM OF \$550.00. THAT HE CEASED THIS EMPLOYMENT AND CEASED THIS LABOR ON THE FIRST OF APRIL, 1925 AND THAT HE WAS EMPLOYED BY THE OFFICERS OR AGENTS OF THE DEFENDANT CARSON MILL & FLUME COMPANY. THAT THE SAID SUM OF \$550.00 IS DUE AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS.
