R. F. HOLLENBECK, OF SKAMANIA COUNTY, WASHINGTON, CLAIMS A LIEN UPON 200,000 FEET OF SAW LOGS WITHOUT BRAND OR MARK WHICH WERE CUT IN SKAMANIA COUNTY, STATE OF WASHINGTON AND ARE NOW LYING IN THE TIMBER ABOUT ONE-HALF MILE SOUTHEAST OF THE MILL OF THE CARSON MILL & FLUME COMPANY, LOCATED ON BEAR CREEK, ABOUT SIX MILES NORTHEAST OF CARSON, SKAMANIA COUNTY, WASHINGTON, FOR LABOR PERFORMED UPON AND ASSISTANCE RENDERED IN CUTTING SAID LOGS; THAT THE NAMES OF THE OWNER OR REPUTED OWNER IS CARSON MILL & FLUME COMPANY AND C. C. SHAY; THAT SAID CARSON MILL & FLUME COMPANY AND C. C. SHAY EMPLOYED CLAIMANT TO PERFORM SUCH LABOR AND RENDER ASSISTANCE UPON THE FOLLOWING TERMS AND CONDITIONS, TO-WIT: THAT SAID CARSON MILL & FLUME COMPANY AGREED TO PAY CLAIMANT FOR HAULING LOGS AT \$1.00 PER THOUSAND FEET IN THE LOGGING CAMP; THAT THE LABOR PERFORMED WAS THAT OF HAULING LOGS IN THE LOGGING CAMP OF SAID CARSON MILL & FLUME COMPANY AND C. C. SHAY; THAT SAID CONTRACT HAS BEEN FAITHFULLY PERFORMED AND FULLY OBLIED WITH ON THE PART OF SAID CLAIMANT WHO HAULED 339,750 FEET OF LOGS; THAT SAID LABOR AND ASSISTANCE WAS SO PERFORMED AND RENDERED UPON SAID LOGS BETWEEN THE 17TH DAY OF JUNE, 1925 AND THE 17TH DAY OF JULY, 1925, AND THE RENDITION OF SAID SERVICES CEASED ON THE 17TH DAY OF JULY, 1925 AND THIRTY DAYS HAVE NOT ELAPSED SINCE THAT TIME; THAT THE AMOUNT OF CLAIMANT'S DEMAND FOR SAID SERVICES IS \$339.75; THAT NO PART THEREOF HAS BEEN PAID AND THERE IS NOW DUE AND REMAINING UNPAID THEREON AFTER DEDUCTING ALL JUST CREDITS AND OFFSETS THE SUM OF 339.75 IN WHICH AMOUNT CLAIMANT CLAIMS A LIEN UPON SAID LOGS; THAT SAID CLAIMANT ALSO CLAIMS A LIEN ON ALL SAW LOGS AND TIMBER PRODUCTS NOW OWNED BY SAID CARSON MILL & FLUME COMPANY AND SAID C. C. SHAY, OF SAID COUNTY, TO SECURE THE PAYMENT FOR WORK AND LABOR PERFORMED IN OBTAINING OR SECURING SAID LOGS.
